

## Coercive control reform tracker: Australia 2026

Orange shading indicates coercive control consideration and reform since February 2020

The purpose of this table is to capture and track coercive control reforms for intimate partner and family relationships across Australia, emphasising those reforms since the murder of Hannah Clarke and her children in February 2020. In some jurisdictions there are additional laws not included in the table below which may provide protection (for example, Peace and Good Behaviour Act 1982 (Qld)) but the purpose of this table is to capture the more specific domestic and family violence laws.

The bill amends the <i>Domestic and Family Violence Protection Act 2021 (Qld)</i> by introducing a new framework for police to issue police protection directions (PPDs). The goal of this reform is to improve efficiencies for police responding to domestic family violence by removing the interaction with the judicial system. PPDs will have a duration of twelve months and can contain the same conditions as a full domestic violence order. The provisions relating to PPDs will come into force on 1 January 2026 (see <a href="#">proclamation</a>).</li> <li>Protection orders are made for people in 'relevant relationships' under the <a href="#">Domestic and Family Protection Act 2012 (Qld)</a>. Relevant relationships include intimate personal relationships, family relationships and informal care relationships (<a href="#">s13</a>).</li> <li>1 August 2023, the <a href="#">Domestic and Family Violence Protection (Combating Coercive Control) and Other Legislation Amendment Act 2023 (Qld)</a> amended the <a href="#">Domestic and Family Protection Act 2012 (Qld)</a>, introducing 'a pattern of behaviour' into the meaning of domestic violence. Each paper targets a different community of people who are impacted by coercive control. <a href="#">The page</a> was last updated on 15 September 2025.</li> <li>29 August 2023, the SA Government opened <a href="#">public consultation</a> on its draft Criminal Law Consolidation (Coercive Control) Amendment Bill 2023 (SA). As part of the consultation, the Government released the <a href="#">Coercive Control Community Guide</a>.
